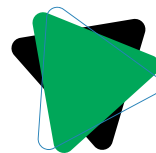

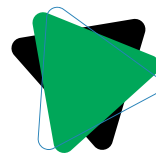

- 7) Festive season support (EID holidays)



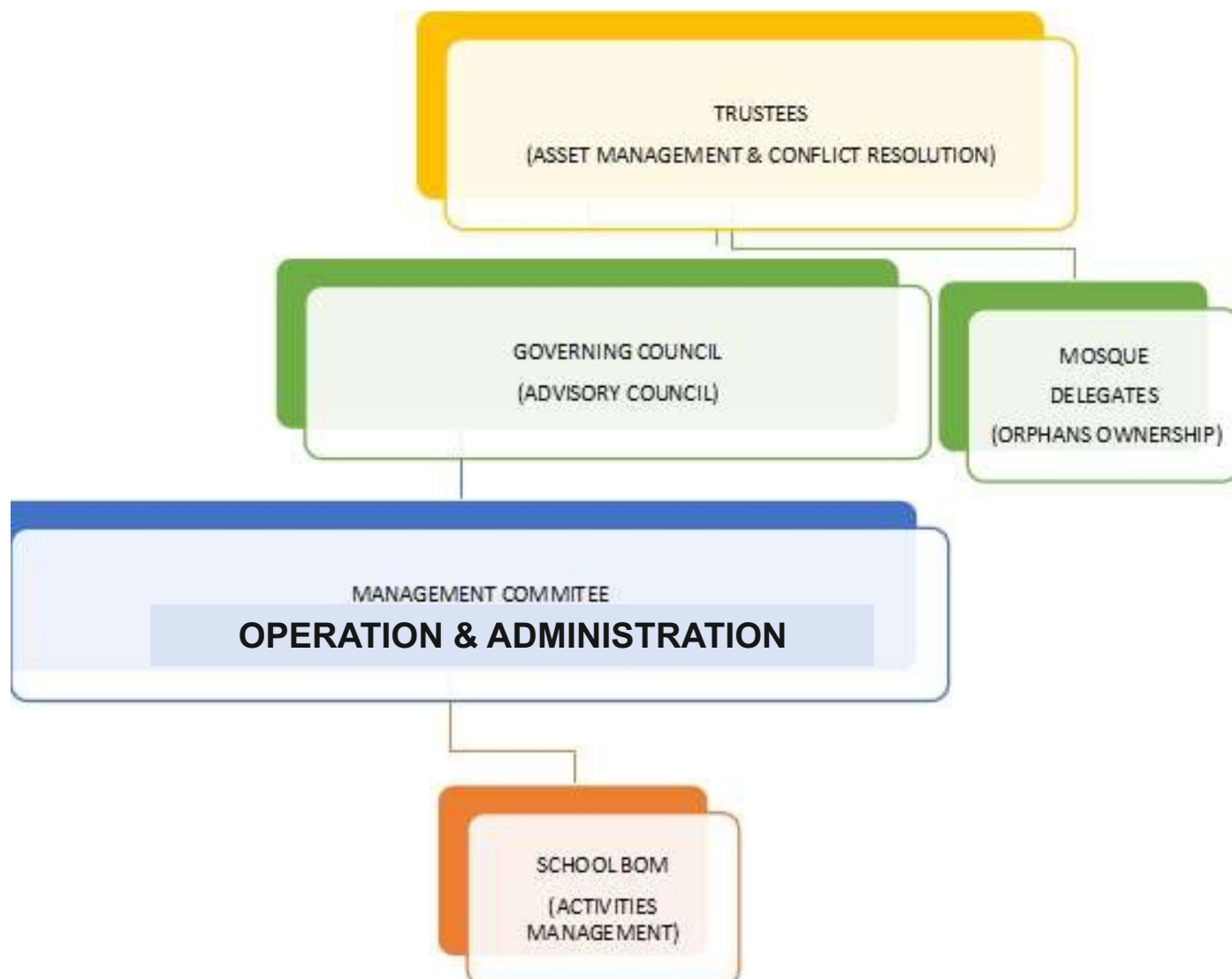


# ► MICO ORGANOGRAM

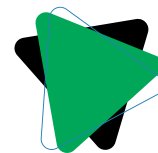
## ► MANAGEMENT COMMITTEE

This is a seven-member central committee entrusted to running of all the operational activities of the Organization. Orphans are registered by the secretariat after going through vigorous recruitment process from the member Mosques. Orphan registration requirement include: -

- The Orphan born from a Muslim family
- Resident of either Malindi Town or Watamu
- Evidence of Marriage certificate/Affidavit
- Death certificate of the Father
- Orphan Birth Certificate/Notification of Birth
- Mothers/Guardian identification card.
- Passport photo

Due to ever increase in demand to admitting and providing consolidated and better services to the Orphans, the Organization have strategically plan to invest in fixed Assets to generate steady income stream.

*Below is an architectural sketch for an investment we wish to construct this year which will cost approximately 120 million and will hopefully generate monthly income of ksh.500,000/= when completed. This will supplement the financial support we receive frequently.*

- Swimming pool - 11 million
- Computer lab & resource Centre -12 million.

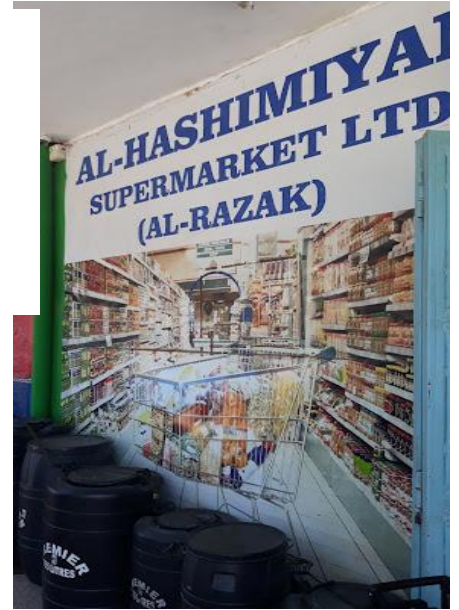
